Project Summary:

An air quality sensor will be mounted using screws or hardware to a fixed surface approximately 6-12 feet from the ground and will be fixed in this location for the duration of the project (at least 9 months) as part of the EJ Air Monitoring Network's particulate matter sensor project. Data will be collected and shared online to estimate particulate matter concentrations throughout Mountain View and the South Valley neighborhoods.

As part of the installation, I agree to the following conditions:

- I grant permission for the monitor to be mounted by metal hose clamp or metal screws on the property.
- I will provide EJ Air staff access to the monitor for periodic inspection, maintenance, repairs, or replacement (within 72 hours notice in normal business hours).
- I will notify EJ Air project staff immediately if I observe any type of equipment malfunction, installation problems, potential weather damage, vandalism, or theft.

I acknowledge that I have been advised and understand that:

- EJ Air is a program of the Valle de Oro Environmental and Economic Justice Strategic Plan and is not a government agency.
- The purpose of installing the monitor is to collect air quality data for EJ Air's community air quality monitoring project.
- Data collected from this and other project monitors will be made publicly available. The
 monitoring data will also be shared with interested entities, such as governmental agencies,
 universities, elected officials, health organizations, etc.
- The air quality monitoring equipment is not dangerous to my health or safety. It is a solar powered device and does not require an electrical power source.

- The property's residence and/or staff are not required to provide any personal information.

 The only information required is the address and contact information, which will be used to find the coordinates- required to deploy the monitor to the online data dashboard and allow EJ Air staff to contact the host with important updates.
- This agreement is voluntary for 9 months and will be extended if needed.
- I may stop participating at any time. If I end my participation, I will provide a minimum 30 days' notice to EJ Air who will be required to remove all equipment.
- EJ Air will hold me harmless and will be responsible for all loss or liability that results from installation or use of the monitor, except to the extent resulting from my gross negligence or willful misconduct.
