South Valley Preparatory School /Finance Committee Recommendation

The South Valley Preparatory School Finance Committee, as the financial oversight body, requests the Governing Council consider for approval the following recommendation:

As a critical financial oversight body of the school and to ensure compliance with the school's procurement policy, the Governing Council is requiring the following:

Current non-instructional contractors to provide

- 1. Itemized statements (invoices and detailed quotes) that clearly outline the nature of the goods or services, quantity, unit costs, including labor, and total cost, allowing the committee to verify expenses against the approved budget and relevant policies*
- 2. Evidence of completion and alignment of charges – all non-instructional contractors providing services on campus must sign in and out, providing a process for SVP to ensure invoiced hourly charges align with hours worked*

In addition, the Governing Council requests that the SVP Administration maintains due diligence by seeking additional quotes from other vendors for non-instructional services such as maintenance, repairs and other purchases of goods and services to ensure price reasonableness.

Motion to approve B.Fricze, 2nd by B.Barreras. Motion passes 4-0, with one member position vacant.
