In the event of a dispute between the Partners in the negotiation of the final binding contract relating to this Project, a dispute resolution group will convene consisting of the leaders of each partners' organizations. In the even the dispute resolution is unable to make a compromise to reach a final decision, it is understood that neither party is obligation to enter into any binding contract to complete the project.

Term

The arrangements made by the partners by this Memorandum shall remain in place from September 14, 2022 until May 17, 2023. The term shall be extended only by agreement of all partners.

Any notice or communication required or permitted under this Memorandum shall be sufficiently given of delivered in person or by certified mail, return receipt requested, to the address set forth in the opening paragraph or to such other address as on party may have furnished to the other in writing.

Governing Law

This Memorandum shall be constructed in accordance with the laws of the State of New Mexico.

Neither party may assign or transfer the responsibilities or agreement made herein without prior written consent of the non-assigning party, which approval shall not be unreasonably withheld.

If any provision of the Memorandum is found to be invalid or unenforceable for any reason, the remaining provisions will continue to be valid and enforceable. If a court finds that any provision of the Memorandum is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision will be deemed to be written, construed, and enforced as so limited.
